**WILDFIRE SEASON:** The possibility of an evacuation from your home increases. Be prepared with a home evacuation kit. This could easily be a suite case or gym bag that contains:

- a couple changes of clothes (shirt, pants, underwear, socks, shoes, rain gear), personal protective equipment (gloves, hat)
- copies of important documents (birth certificate, passport, drivers license, etc.),
- any required medications, eye glasses / contact lenses
- toiletries (toothbrush, toothpaste, personal cleaning products, toilet paper, etc.)
- First aid kit / flashlight
- 2 litres of water per person
- 3-day supply of non-perishable foods (power bars, protein bars, etc.)

Make an emergency kit for each member of your house hold. And an equivalent emergency kit for each pet that you will be taking with you. Keep the emergency kit(s) in a handy place so that you can get to it in moments. Remember, it is not a case of if, it is a case of when.

# DID YOU KNOW.....

- The County of Two Hills including the Village of Myrnam and the Town of Two Hills has approximately 85 volunteer firefighters.
- That protective bunker gear (coat and pants) can range from \$2,000 per set and up to \$8,000 per set depending on the type of outer shell, inner liner and accessory options.
- That bunker gear does not last forever.
- That volunteer men and women have full time jobs and still respond to fire calls, motor vehicle accidents, medical assists 24 hours a day, 365 days a year.
- That the volunteer firefighters maintain the fire halls and Equipment completely on their own time.
- Did you know that any fire response is billable and you may receive an invoice, fire response is NOT covered by property taxes.
- Fire Departments are always looking for additional volunteer firefighters, contact the County of Two Hills or your local fire department.
