Farm Family Award

Roadside Spraying

Roadside Seeding E. Kozak informed the Committee that Roadside Seeding for 2014 construction has been completed.

Pest Surveys E. Kozak presented the following Pest Survey Updates:

- Diamondback Moth, low counts have been recorded.
- Bertha Armyworm, low counts have been recorded.
- Grasshoppers are at the threshold, some farmers are spraying.

E. Kozak presented information regarding the NW 14-54-13-W4 crossing.

E. Kozak informed the Committee of the Oxide Daisy located in the Town of Two Hills.

It was consensus of the Committee that Administration spray weeds in the Town of Two Hills on a cost recovery basis.

It was also consensus of the Committee that Administration investigate and spray if necessary, the weeds in all hamlets throughout the County.
