Fin Report

There being no business arising from the minutes, the Financial Report for the period ending May 26, 2014 was presented for review and consideration; it was moved by:

K. McLaughlin presented the following new and other business:

Gas Rate for June 2014 – \$0.40 /gj increase

Residential Commercial June 2014 - \$5.29/gi June 2014 - \$4.87/gi May 2014 - \$4.89/gj May 2014 - \$4.47/gj

- Gas Balancing Report for month of April 2014 + 1.6%.
- Retail Gas Sales Comparison Report was presented and discussed.
- County of Vermilion River Anniversary BBQ was presented and discussed.

Equalized Billing was discussed. It was the consensus of the Committee that the Gas Utility Administration monitor equalized billing accounts, contacting customers to arrange any billing amount changes required.

- K. McLaughlin informed the Committee of Growing Power gas rates.
- K. McLaughlin informed the Committee that 86 customers have requested that return envelopes be included with their gas billings.
- K. McLaughlin informed the Committee that 26 meter changes remain for 2014 and 3 meter changes remain for 2013.
- K. McLaughlin informed the Committee that 249 meters remain without ERTs, of these 19 remain on Tap 80 and 5 remain on Tap 90.
- K. McLaughlin informed the Committee that to date there are two customers that would rather not have ERTs installed or activated. It was the consensus of the Committee that the Gas Utility Manager prepare a draft letter regarding the purpose of ERTs and the associated costs to stay on a manual read meter.
- K. McLaughlin informed the Committee that the Gas Utility Department completed a total customer meter reading during the week of May 26 30, 2014.
- K. McLaughlin informed the Committee that Corrpro Canada Inc. completed a cathodic protection survey of the Village of Myrnam, Remote Metering Odorizing stations and low pressure taps (downstream regulating stations) on May 21-23, 2014.
- K. McLaughlin informed the Committee that Corrpro Canada Inc. has informed that approximately 144 isolated low pressure steel crossings exist within the gas system that were last checked in 1980. It was the consensus of the Committee to proceed with Corrpro Canada Inc. to complete the cathodic protection survey with costs not to exceed the estimate of \$7,500 to \$7,700; once completed the Gas Utility will assume the responsibility of testing.

It was also the consensus of the Committee that the Gas Utility Manager contact Metercor and arrange for Tap 20 (completed ERTs) and any other completed taps to be activated and added to the billing system.

- K. McLaughlin informed the Committee that there are 21 rural/urban infill requests to date.
- K. McLaughlin informed the Committee that there are 9 Husky tie in requests 5 in 54-06-W4 and 4 in 53-06-W4.
