- K. McLaughlin informed the Committee that to date, all the required repairs except those to Tap 80 have been completed with regards to the Cathodic Protection Survey completed May 21-23, 2014 (Corrpro Canada). Tap 80 will be completed by July 4, 2014.
- K. McLaughlin informed the Committee that Corrpro Canada was out June 10 13, 2014 to complete the cathodic protection survey on the isolated low pressure steel crossings that exist within the gas system. No report received to date.
