The CAO informed the Committee of the Husky Transportation Vent Gas Agreements and CNRL added sites for agreement confirmation; agreements should be executed by month end.

The CAO informed the Committee of the Federation Gas Balancing Course to be held on March 6, 2015 in Sherwood Park.

The CAO informed the Committee of the Rural Gas Service Pins that may be ordered through the Gas Federation.

It was the consensus of the Committee that Administration arrange to present Rural Gas Service Pins to eligible Natural Gas Utility Committee members and staff at the 2015 County of Two Hills Safety Barbeque or Christmas Event.

The CAO updated the Committee on Cathodic Protection – staff is currently mapping lines; would like to change the line and insert new tracer wire when working in the same location.
