- D. Dyck informed the Committee of the ERT's Update Taps 10, 20, 30, 40, 50, 60 & 80 complete, Tap 70 in progress.
- D. Dyck informed the Committee that staff completed ERT Training for RUBIS billing purposes July 6 and 7, 2015.
- P. Gordeyko, placed the new billing system on the table for discussion.

It was the consensus of the Committee that Administration include information in the next Gas billing to advise ratepayers of the new billing system in place and to report any discrepancies.

- D. Dyck informed the Committee of 2015 Meter Reverification -558 total and 379 changed to date.
- D. Wilson presented an update of the Operations & Maintenance Evaluation:
 - Leak Detection Waiting for Leak Detection Report from "Tangle Ridge" for the aluminum and steel lines.
 - Tap 10 to 20 Loop TransCanada Pipeline (TCP) has confirmed a reconnection. Plans still in progress for November 2015 completion date.
 - New Tap 60 Feed TransCanada Pipeline (TCP) confirmed a reconnection. Plans still in progress.
 - Cathodic Protection: Repairs complete in Myrnam.
- D. Dyck informed the Committee that the County Gas Engineers have recommended that Administration investigate and prepare a long term capital plan over the next 25 years for the steel gas line replacement.

It was the consensus of the Committee that Administration investigate and prepare a 25 year capital plan for the replacement of steel gas lines within the County of Two Hills franchise area.

- D. Dyck informed the Committee that the Truck Tool Kits have been completed.
- D. Wilson informed the Committee that the Heater Repair Replacement Plan is in progress.
- D. Wilson informed the Committee that Rife Resources re-route job is complete.
- D. Dyck informed the Committee that the gas loss on Tap 80, is being investigated.
- D. Wilson informed the Committee that a CNRL meter is being upgraded, as a larger gas supply is required.
