Mr. Keith Austin was invited into Committee Room to discuss the Haul Road Agreement and the required \$6,500.00 per mile.

Gravel Crusher

- Moved to Boyko Pit; crushed 5,000 yds of 3/4 inch E.G.
- Pre-screening of finds was necessary to eliminate clay content

Construction

 Construction crew started construction on RR 94 north of Hwy 45, 1/2 mile progress has been made; rain has been an issue

Operations

- Rain has limited the gravel deliveries and the ability to gravel County roads
- Crew began work drying and packing base on Boian base pave project

Gravel Haul Routes

Highway Rock Product haul route; road damage needs to be repaired

Lahrmann Pit

 AMEC proceeding with Code of Practice for the Lahrmann Pit; to be submitted and completed within next month and a half

Gravel Haul

- County forces have been hauling out of Myrnam Pit; trying to do patching when conditions allow
- Contract truckers hauling out of Myrnam Pit; gravelling grid area, weather permitting
- Now hauling out of Boyko Pit

General Items

- R. Bouchard informed the Committee of the Sandy Lake Pavilion cookhouse quotes; will acquire at least 3 quotes.
- R. Bouchard informed the Committee that the dock has to be installed at Lac Sante and the boat launch has to be repaired.
- R. Bouchard informed the Committee that Public Works is still in the process of hiring a grader operator for Derwent South. The CAO informed the Committee that employment ads will run this week.
- R. Bouchard informed the Committee that a complete round of grading was completed between rains, any roads missed will be investigated and completed.
- R. Bouchard informed the Committee that ADL system was down for a month. The CAO informed the Committee that it will be investigated on July 4, 2014.
- R. Bouchard informed the Committee that Jackfish Lake received approximately \$7,900.00 in overnight stays; Sandy Lake \$2,782.00 in overnight stays. Upgrades to Sandy Lake showers was discussed.
- A Committee Member suggested completing more graveling/maintenance of the grid system. The CAO informed the Committee that a call from a ratepayer was received stating the same.
