#### **General Items**

The CAO informed that a ratepayer informed of concerns regarding dust control damage on NE 36-55-14-W4, noting damage was caused by a third party company. It was the consensus of the Committee to provide dust control in 2015 at no charge.

The CAO informed the Committee of correspondence received from MLA Shayne Saskiw regarding the status of a road stretching 4 miles on the west end of Willingdon (RR 152 and Twp 562, near Shandro Bridge on Hwy 45). It was the consensus of the Committee that Administration respond to the same.

The CAO informed the Committee of correspondence received from MLA Shayne Saskiw regarding the application for a road name sign, being Angle Lake Road, on Twp 552 west of Hwy 41. Noting that at the August 8, 2014 Public Works Committee Meeting it was the consensus of the Committee to follow the Historical Road Identification policy PUB-SIGN-1 and deny the request to pay for the said sign. It was the consensus of Committee that Administration forward to MLA S. Saskiw a copy of the Historical Road Identification policy PUB-SIGN-1.

The CAO informed the Committee of the Private Gravel Sales policy PUB-GRV-3. It was the consensus of the Committee that this item be deferred to the October Council Meeting.

R. Bouchard updated the Committee of the status of water line repairs in the Hamlet of Derwent.
