Construction

- RR 141 north of Hwy 645 2 miles complete
- Twp Rd 570 east of RR 141 ¹/₂ mile complete, now working west of RR 141 for ¹/₂ mile
- Construction crew will be stripping and preparing pit at Esak's Pit
- Culverts installed on RR 73 south

Gravelling

R. Bouchard placed graders on the table for discussion. R. Bouchard informed the Committee that there are four graders close to buy back hours (6,000).

It was the consensus of the Committee that Administration be authorized to contact Strongco and advise that the County of Two Hills will be returning the Grader(s) as per back hours. Furthermore, obtain quotes for replacement grader(s).

RatepayerS. Dary informed the Committee of a letter received from a ratepayer regarding a
guardrail on RR 153 and Twp Rd 550.

It was the consensus of the Committee that there are adequate approaches and access to the NE 33-54-15-W4M and that the current guardrail structure is designed for safety purposes. Furthermore, that changes to the culvert may cause a diversion of water which must be authorized by Alberta Environment.

St. Michail
A. Sayler placed a letter of request from St. Michail Cemetery Co., NE 36-53-9 W4M on the table for discussion, stating that the landowners are requesting removal of a windrow (wood and debris piles) which was previously burnt on the east side of the cemetery.

It was the consensus of the Committee that the Public Works Supervisor investigate and report back to the Committee.

RatepayerS. Dary placed the NW 5-56-14-W4M on the table for discussion, referring to a
letter sent in follow up with Committee meeting held on January 5, 2015. S. Dary
noted that the landowner is requesting compensation following the investigation.

The Committee having discussed this item, it was moved by:

That there be no further compensation paid to the landowner on NW 5-56-14-W4M as per Payment for Crop Policy PUB-CRO-1.

UnsightlyS. Dary placed the cleanup for the unsightly property in the Hamlet of Hairy HillProperty –on the table for discussion, noting that the cleanup costs are in the amount ofHamlet of Hairy\$8,038.00, having this amount being added to the tax roll on Lot 5, Block 3, PlanHill712EO.

RatepayerP. Gordeyko placed a request from a ratepayer to lower the sign at the bridge on
NE 27-54-12-W4M.

Policy PUB-E. Yakemchuk placed Private Gravel Sales Policy PUB-GRV-31 on the table for
discussion, requiring clarification of the policy.

Waste DisposalE. Yakemchuk placed Waste Disposal Bins on the table for discussion, noting that
the bins are overloaded at times in specific areas of the County of Two Hills.

The Committee having discussed this item, it was moved by:

E. YAKEMCHUK

That the County of Two Hills place additional waste disposal bins as follows: (2) two at the main area of Lac Sante, (1) one at LaBreque's, and (1) one in the Hamlet of Morecambe.

It was the consensus of the Committee to investigate a long term plan for the waste disposal bins within the County of Two Hills.

Hairy HillS. Odegard placed the Hairy Hill Community Hall Playground on the table for
discussion, providing details of the overall plan and confirming that the County of
Two Hills grant money is a maximum of \$30,000.00.

It was the consensus of the Committee that the Public Works Supervisor track the costs associated with the in-kind work provided by County of Two Hills for the Hairy Hill Community Hall Playground to the maximum of \$30,000.00 and to advise the group once they have reached the maximum amount.

The Committee having discussed this item, it was moved by:

S. ODEGARD

That the County of Two Hills authorize the Hairy Hill Community Hall Playground located on Lot 1-2, Block 2, Plan 712EO in the Hamlet of Hairy Hill to utilize the right-of-way 12 feet by 120 feet (containing approximately 0.1 acres) adjacent to Railway Avenue for drainage purposes at a 3:1 slope, furthermore that the 3:1 slope be maintained in the future by the Hairy Hill Community Hall.
