#### **BYLAWS & POLICY:**

**Bylaw No. 01-2023:** Council duly enacted Bylaw No. 01-2023, Section 256(1)(2)(3) of the Municipal Government Act authorizes the borrowing of monies for the purpose of financing operating expenditures. The amount to be borrowed must not exceed the estimate to be raised in taxes in the year of borrowing and the Bylaw does not have to be advertised if the borrowing term does not exceed three years.



#### **PAYMENT INFORMATION**

#### Payments may be made:

At the County Office by cash, cheque, debit or credit card.

On the County Website: Property Tax may be paid by credit card, processed online the County's website at <a href="https://www.thcounty.ab.ca">www.thcounty.ab.ca</a> through OptionPay. If you choose to make a payment with a credit card, please be aware there is a 3% service fee that will be processed on the credit card at the time of transaction.

With your Bank: If you pay your taxes by bank teller or internet banking, please choose **COUNTY OF TWO HILLS** as the Payee. Please DO NOT PAY your County of Two Hills property taxes to the Town of Two Hills.

Internet banking can be used if you bank with any of the following institutions: TD, ATB, BMO, any Credit Union, CIBC and Scotia Bank. Please use your **Roll Number** as your Account Number.

#### **Monthly Pre-Authorized Payment Plan:**

The County of Two Hills has monthly pre-authorized debit for Property Taxes. Please be advised that to be eligible for the monthly pre-authorized payment plan, property taxes must be in good standing, having no taxes owed.

#### **SNOW PLOWING**

With the onset of winter, the Public Works Department would like to remind residents that the snow plowing of driveways will be available to full-time residents that qualify.

As part of the snow clearing policy: **BUS ROUTES WILL BE GIVEN FIRST PRIORITY FOLLOWED BY COUNTY ROADS** before driveways are cleared, so please be patient as the Snow Clearing Crew will do their best to reach qualifying residents in a timely manner. Further, snow flags will no longer be required.

- Seniors \$100 per year
- Full Time Residents \$250 per annum on November 1 and onward
- Custom Snow Plowing flat fee of \$200, additional hours as per Fees Schedule.
- Home Care and Bus Turnarounds no charge.
- Fees do not change if there is abundant snow or no snow.

Lastly, due to safety concerns, the County of Two Hills asks residents to fully clear County roads of residual snow left when clearing driveways and piling into ditches. Leaving the two ridges is a driving hazard and if an accident occurs the landowner is liable.
